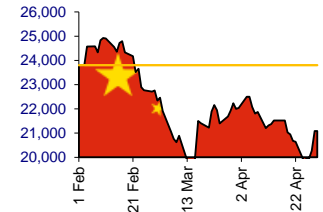
S&P 500 - 3 Month

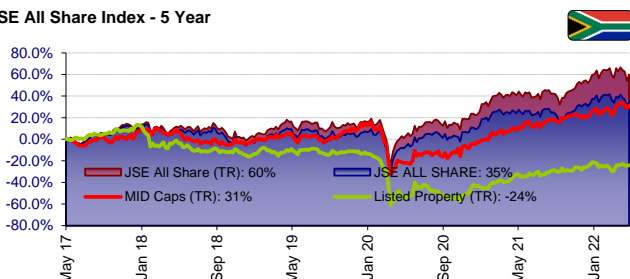

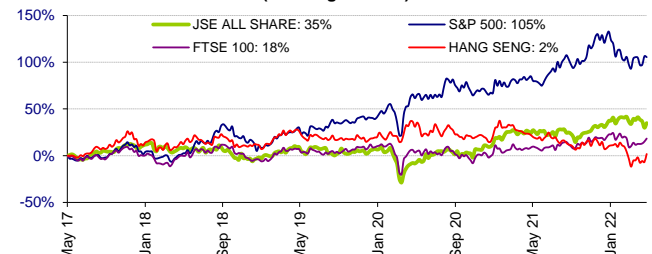

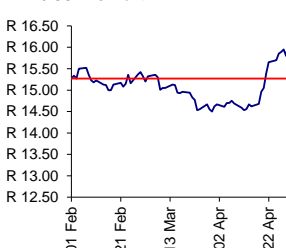


JSE All Share vs. World Indices (% change in ZAR) - 5 Year

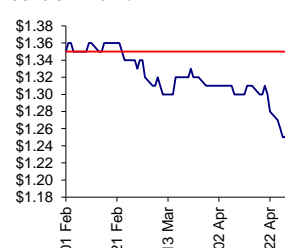

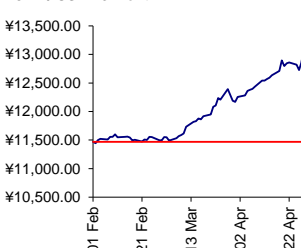

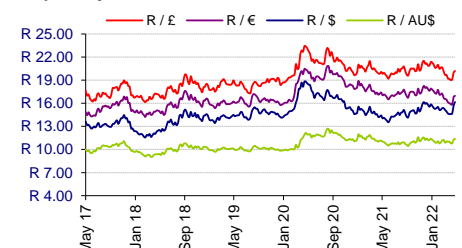
USD / GBP - 3 Month

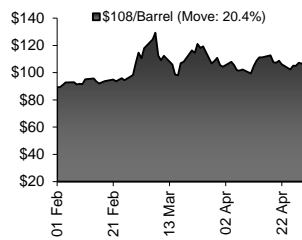

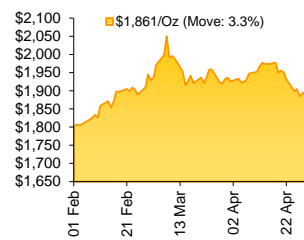

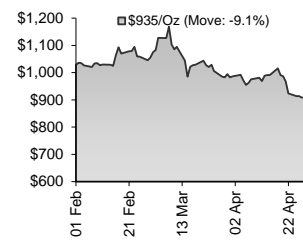
Brent Cr (\$/Barrel) - 3 Month



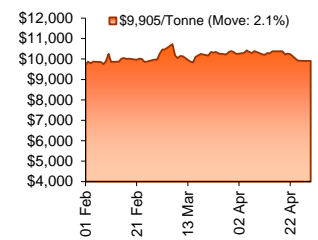
Gold (\$/Oz) - 3 Month

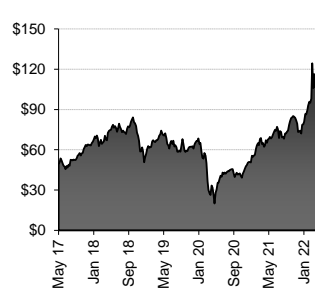

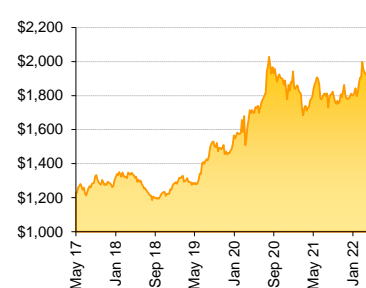

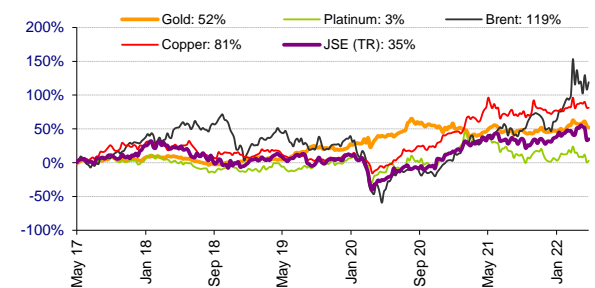
Brent Crude \$/Barrel - 5 Year



Gold \$/Oz - 5 Year



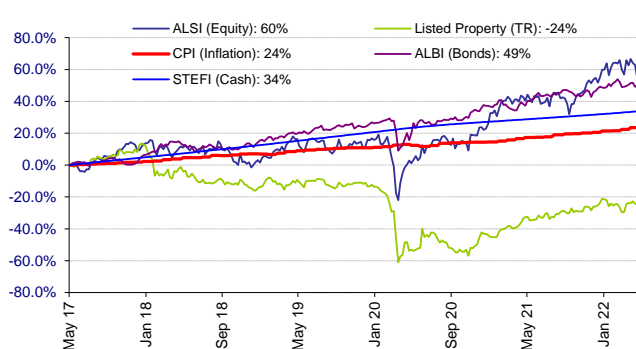

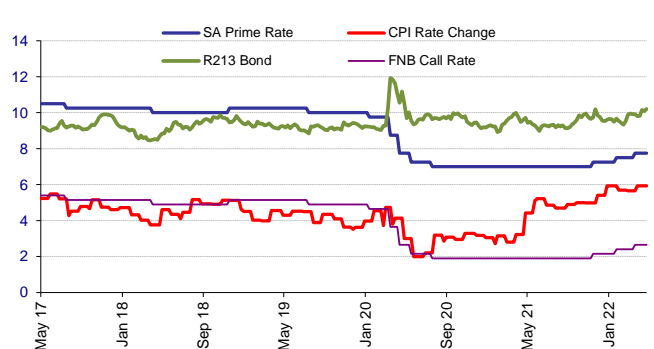
